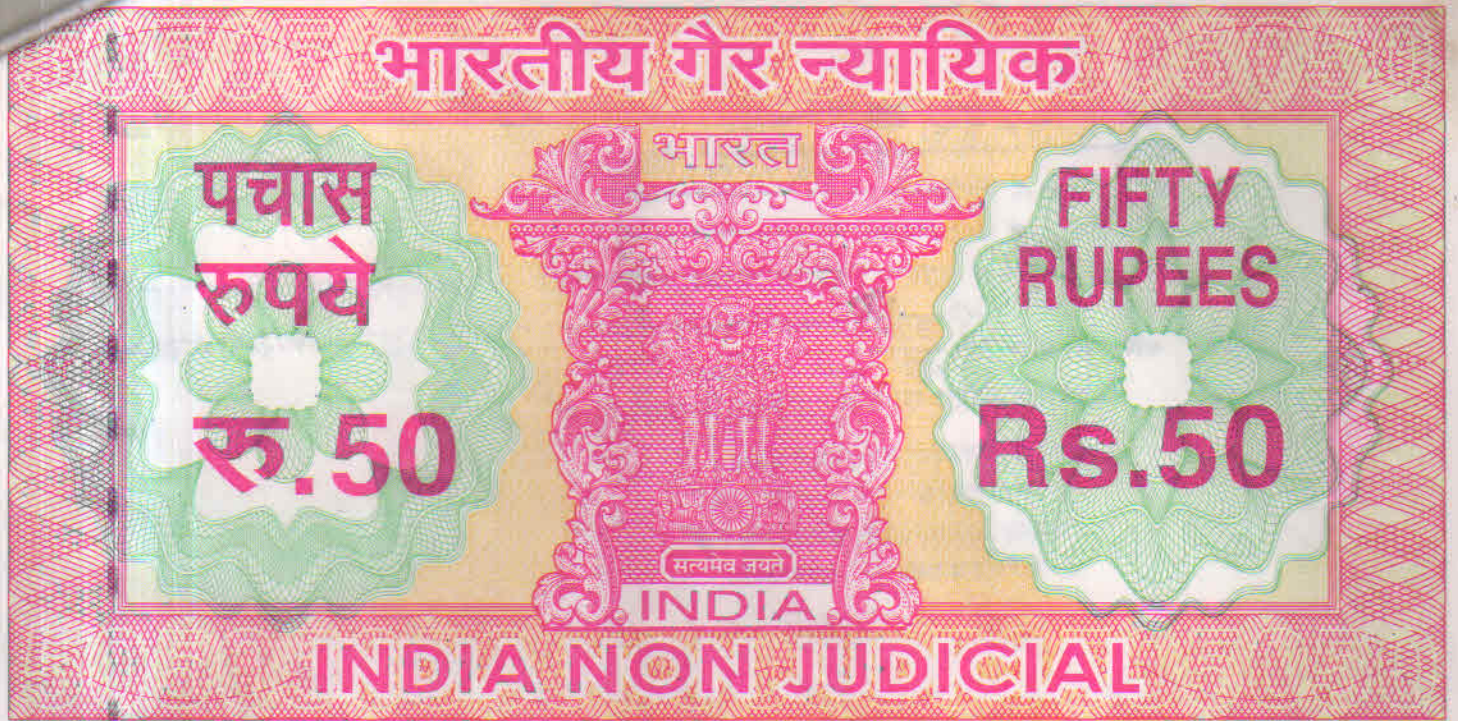

5.5 ACCUMULATION:
